The volumetric weight of your parcel should be calculated as follows

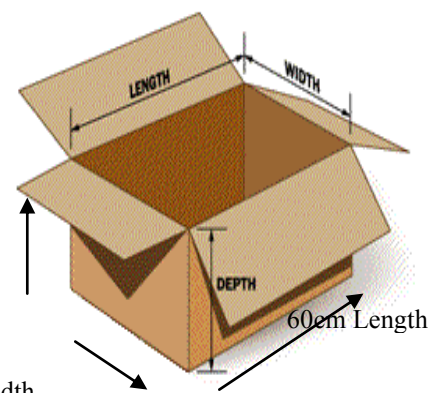
Length (cm) X Height (cm) X Width (cm)

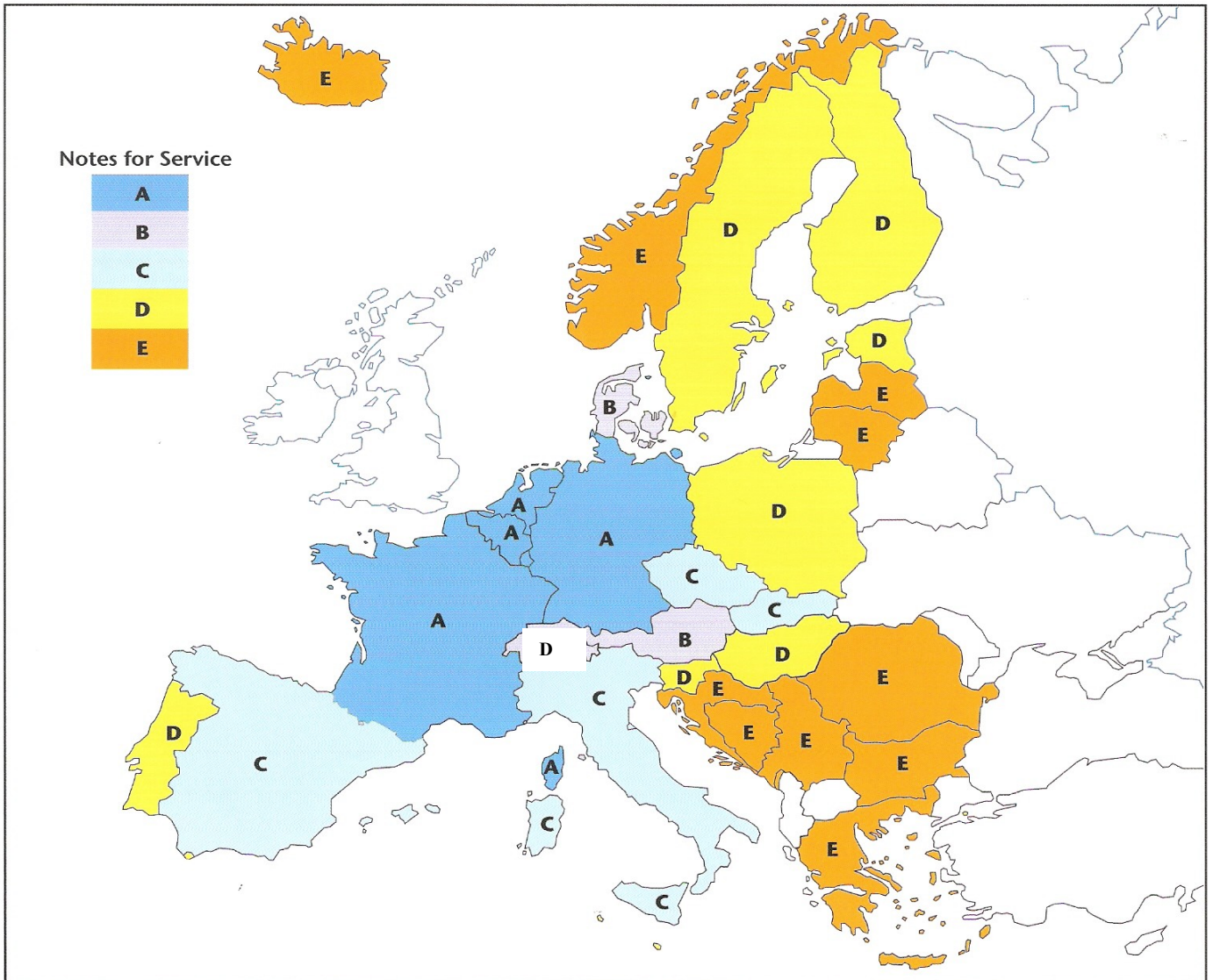

1. When the volume of goods exceeds 3.0 cubic metres per tonne, the company charges on whatever is the greatest, volume or weight.
